

Max Rehab & Sport
Batting Cage Rental Agreement & Rules and Regulations

Batting Cages must be paid in full prior to the rental date.

Groups will need to review and sign a rental contract.

Individuals must review and sign the release of liability. Parent/guardian signatures required for all minor participants.

Batting cages may be booked up to two weeks prior to rental.

Batting Cages rent for \$50 per hour per cage.

Batting cage rentals include:

- ✚ Pitching machine (please specify baseballs or softballs on the Rental Request Form)
- ✚ Baseballs or softballs
- ✚ L-screen to protect participants
- ✚ Home plate
- ✚ Participants should bring their own bats and helmets.

Each cage rental is for 60 minutes that includes 10 minutes of each hour allocated for set-up and take-down of the machine or for switching from baseballs to softballs or vice versa.

In the event of cancellation, 48-hour notice must be given to receive a full refund (minus the \$5 service fee)

Max Rehab & Sport reserves the right to reject any rental cage request.

Rules and Regulations

Failure to abide by these regulations may result in disciplinary action and the possibility of ejection from the facility:

- First time users must undergo a brief equipment orientation with the Max Rehab & Sport staff.
- Youth under the age of 14 must be accompanied by an adult.
- Adults are responsible for the actions of the youths in the batting cage. Misconduct will result in immediate termination of privileges.
- Closed-toed shoes must be worn.
- No cleats allowed.
- No food or drink allowed.
- Batters must wear helmets at all times while in the batting cage; helmets are not provided.
- All participants should stay in the batting cage area.
- When pitching you must stand behind the safety net.
- Spectators and those not batting or pitching need to stand outside of the netted area.
- Please take practice pitches before inviting the batter into the cage.
- The only people swinging a bat are those in the cages.
- No bat to ball contact outside the batting cages.
- No hitting outside the batting cages.
- No soft toss allowed outside the cages.
- Once your time is up, please put all balls back into the bucket and put the bucket back in the storage area.
- Fee must be paid and waiver form must be signed before using the batting cages-if the participant is under 18, a parent or legal guardian must sign the waiver form.

Max Rehab & Sport Batting Cage Rental Agreement

____ I have received and read the Max Rehab & Sport Rental Regulations for the facility. I have requested and agree to and will abide by those rules and regulations before, during and after the event.

____ I understand that I must be over 18 to be the responsible party for this rental and that I must be present for the duration of the rental.

____ I understand that Max Rehab & Sport reserves the right to approve or deny any rental request and to cancel or move any scheduled event without liability as detailed in the Facility Rental Regulations.

____ I understand that I must pay my balance in full at least 2 weeks prior to the rental date or my rental may be cancelled.

____ I understand that cancellations must be submitted in writing to Max Rehab and Sport, by the person who signed the contract, at least 2 days prior to the event in order to receive a deposit refund (minus \$5 service fee) and that refunds will not be granted to cancellations made less than 2 days before event.

____ I understand that I shall be liable for any and all costs for services already performed that are associated with this request, including reasonable attorney legal fees, if necessary.

____ I understand that I am responsible to see that all activities are properly controlled and supervised for the conduct of all guests attending the event as outlined in the Facility Rental Regulations and that conduct breaches may result in financial penalties.

____ I understand that I may be asked to reduce noise levels. If compliance is not met, renter violates agreement of contract and may be asked to leave and lose future rental privileges and deposit.

____ I understand that the rental is for 60 minutes that includes 10 minutes of set-up or take -down.

____ I agree to leave and make sure all guests have departed by the designated end of event and that failure to comply with timely departure will incur forfeit of deposit.

____ I understand the clean-up duties that are required of me include returning the cages to the same condition in which it was found at the beginning of the event and that failure to meet these duties may forfeit deposit.

____ I understand that the consumption of alcohol is prohibited on all Max Rehab & Sport property without a permit and that smoking is prohibited inside and outside all facilities.

____ I agree to abide by all terms and conditions set forth in the facility rental regulations and that failure to adhere to these regulations will incur financial penalties and possible legal action.

____ I certify that all the information above is accurate and correct. I have read the Facility Rental Regulations pertaining to the use of Max Rehab & Sport facilities and will be responsible for all injuries caused by such use, (2) adhere to the rental hours agreed to through the signed contract and (3) reimburse Max Rehab & Sport for all loss or damage to equipment/property caused by such use. In consideration of participation as specified at the location requested, for the date(s) and time(s) requested, I do hereby release and hold harmless Max Rehab & Sport, LLC and Lauren Bowles, PT from any and all liability or claims for damage of injury to person or property of the undersigned due to permittee's use of said facility(ies), by reason of any act or omission by Max Rehab & Sport or any of its officers, agents, or employees or the condition of its property.
